

Elections Watch Committee (EWC)

Local Government Elections (Mayor and Chairperson) 2023 Mid-Day Statement

20th May 2023

The Election Watch Committee (EWC) is a partnership of 7 organizations with different expertise and background – Peace Ambassadors-The Gambia (PAG), ACTIVISTA, National Youth Parliament (NYP), Think Young Women (TYW), Beakanyang, Peace Hub – The Gambia (PHTG), and The Gambia Federation of the Disabled (GFD) – collaborating to observe the electoral processes in The Gambia. The EWC's observation of the 2023 local government elections will build on the EWC's observation of the 2021 Presidential election including the Voter Registration process, the display of a provisional list of voters, the candidate nomination and campaign period, the 2021 presidential election day and as well the 2022 National Assembly elections. Ahead of the May 20 local government (Mayor and Chairperson) elections, the EWC has observed the candidate nomination process and the campaign period.

Introduction

This midday update is based on reports that the Elections Watch Committee (EWC) received from the 104 stationary observers proportionally deployed to polling streams nationwide on 20th May 2023. Elections Watch Observer reports indicate that the set-up and opening process has been peaceful, orderly, and proceeding smoothly across the country.

The EWC has deployed 128 trained and accredited observers, which include 104 stationary polling stream observers, 10 mobile observers, and 14 regional coordinators. Stationary polling stream observers have been systematically deployed based on a proportional distribution by constituency. This means that the proportion of Elections Watch Committee stationary observers closely matches the overall proportion of the IEC polling streams in each constituency and administrative area. For example, 34% of polling streams where Elections Watch Committee observers are deployed are in Brikama and 34% of overall polling streams are in Brikama. This proportional deployment enables the EWC to comment on the process nationally, drawing on

data points from every constituency across the country. Additionally, the EWC will deploy its 14 regional coordinators to observe the collation process at the IEC's 7 regional collation centers.

This report focuses on findings submitted by EWC observers on the set-up and opening of polling streams on election day. The data reported in this report is based on data on emerging national trends from reports gathered directly from our observers at polling streams. The EWC has received 100% of reports from its 104 stationary observers.

Arrival at Polling Streams

• All Election Watch Observers were at their assigned pollion stream by 7:00am. All observers reported that the Independent Electoral Commision (IEC) staff respected their positions as accredited observers and permitted them to observe at the polling streams.

Set-up

- All Election Watch observers reported that there were 4 IEC staff present during set-up.
- At almost all polling streams with EWC observers it was reported that there were 2 IEC staff members that were women.
- Observers reported that all essential materials (including the voter's list, ballot drums, ballot drum seals, ballot tokens, and indelible ink) were available at all observed polling streams at the time of opening which reflects the good logistical preparation of IEC ahead of the election day.
- In polling streams where Elections Watch observed, the ballot drums were shown to be empty and the ballot drums were sealed in a systematic manner.
- Observers reported that in nearly all polling streams observed the Presiding Officer counted the number of ballot tokens at the polling stream before opening for voting. The Elections Watch Committee notes that the IEC Handbook advises Polling Officials to count the ballot tokens after they receive their materials, which occurs the day before the election.
- Some Elections Watch observers noted that they had to climb stairs to reach the polling stream. Stairs make the polling place inaccessible to persons with disabilities and the elderly which may disenfranchise them from voting.
- In nearly all polling streams where Elections Watch Observers are located, observers saw security personnel stationed during the setup process. In an isolated incident an observer reported that the security personnel arrived after the setup process.

Opening Time

• Elections Watch Observers reported that voting generally commenced on time in most of the observed polling streams. By 8:15 am most polling streams with Elections Watch Observers were reported to open. The remaining polling streams opened between 8:15 and 10:00 am.

Critical Incidents

The Election Watch Committee observers in Banjul reported incidents between NPP and UDP party supporters in different locations within the area. The altercation between the two involved a physical fight. The fight started as a result of the two persons in question trying to campaign for their candidates at the polling stream. It was reported that these incidents disrupted the voting process, as voting was put on pause until the issue was resolved. Voting peacefully continued after the issue was resolved.

In Bakau, the EWC observer reported an incident of a voter in possession of two voter cards. The EWC commends the Presiding officer's actions in seizing the voter cards and not allowing the voter to cast a vote and demands an investigation and a clarification from the IEC on the issue.

Recommendations

- Political party agents continue monitoring the process through voting, closing, and counting in a peaceful manner.
- EWC encourages voters who are still waiting in line to vote to wait patiently and in an orderly manner to exercise their franchise. All voters in the line at 5:00 pm should be allowed to vote.
- The Security Command should ensure that their officers remain vigilant and continue to protect all voters and officials on election duty throughout the remainder of the process.
